Meet Conditions:

1. This meet is open to all financial SNZ registered competitive or club swimmers.
2. Meet will be swum under SNZ/FINA rules.
3. Age as at 23 September 2017.
4. Self-marshalling will operate throughout the meet.
5. This event will be swum short course.
6. During warmup, lanes 1-7 will be for general swimming with no diving for the first 20mins, after which lanes 1, 2, 6, 7 will become sprint lanes with diving, EXCEPT, if required, Lane 7 will be reserved for Para swimmers only throughout the warmup.
7. Swimmers may enter up to 3 events, and **No Times** will be accepted. All events will be swum as timed finals. Event 3 will be limited to 3 heats and selected on the day by blind draw.
8. Entry fees \$20 meet fee per swimmer for 1-3 individual events. Relay free. Entries and payment will be via the SNZ Database. Relay entries to be completed by the Club Administrator.
9. Entries open on 1 September 2017 and close at Midnight (11:59:59) on **Monday 18 September 2017**. Late entries will not be accepted.
10. There will be no refunds for withdrawals once psych sheets are released on Tuesday 19 September 2017
11. Programmes \$2. Spectators \$2 **NO EFTPOS AVAILABLE, CASH ONLY SWIMMERS AND OFFICIALS MUST USE THEIR SWIM WGTN ENTRY CARD**
12. All participants must agree to comply with the Sports Anti-Doping Rules.
13. Para swimmers are eligible to compete at this meet and shall compete under the IPC swimming rules. Para swimmers must present their classification card to the Referee at the commencement of the meet.
14. **By entering this meet, swimmers agree to allow images (e.g. photography, video, etc.) to be taken by accredited media approved by Swimming Wellington. Images are only to be used for legitimate purposes by Swim Wellington in accordance with the SNZ Member Protection Policy.**
15. All clubs must undertake the Duty Club positions as listed below.
16. Swimming Wellington reserves the right to restrict entries, combine events or alter the programme.
17. Swimming Wellington will not be liable for any loss, damage or injury that may occur at this meet.
18. Participating Clubs are to provide officials as requested by RTOP over and above the Duty Club requirements.
